COVID CLAIMS TWO NLBM BOARD MEMBERS

We have been gradually impacted more and more because of Covid-19 since March of 2020. Our families, friends, local congregations, businesses, prisons, and neighborhoods have been forever changed. Within thirty days, Family Upreach lost two of its Board of Trustees: James E. Curry and Gaylord B. Sturgess. Our prayers are with their wives (Linda and Sharon) and families. Both men contributed significantly to "reconciling persons to God, families and society" through *NewLife Behavior Ministries.*

Gaylord Sturgess was the longest continuously serving member of the Family Upreach board. He and Sharon generously contributed to this work with their time, energy, talents, and financial resources. When we needed a hymn, Gaylord would rise to the occasion (singing with the *Gospelaires* quartet for years). He helped keep meetings "light" with his unique style of humor, a story, view of life, its challenges, etc. Gaylord's faith was always brightly glowing. Tackling any





obstacle was begun with prayer and trust in God. He will be deeply missed.

James Curry was evangelistic to the core. He had served both as a full-time missionary and prison minister. The first National Jail-Prison Ministry Workshop (1974) is due to James' passionate leadership. As a trustee of the NLBM board, he served both as Chair and Vice Chair and presented NLBM with a professional binder of meeting minutes annually. James was not content with attending board meetings. He visited inmates one-on-one, attended national workshops and often took part in <u>Reconciled & Renewed Seminars</u> inside prisons on special weekends.

These men are not replaceable. They remind us of how truly "special" God made each of us. Family Upreach will go on and others added to its board but that is not the point. James and Gaylord would tell us to embrace who we are in Christ, individually gifted by God, and responsible for helping shape His world as we live day by day. We are thankful to God, these men, and their families for sharing them with us for a little while. They are now at rest, and we rejoice with them over their *victory in Jesus*.

We would appreciate knowing "which" course has been completed. Since there are significantly more male prisoners, we are especially interested in receiving this information about *female* students.
