
ALL COURSES TO BE NLBM-OWNED CURRICULUM By Dr. Dale Underwood, President

Family Upreach, Inc. began the process in 2023 to own all of the copyrights to the fifteen courses that comprise the NLB curriculum, and it will be completed in 2024. Heretofore, NLBM was granted the privilege to use the material which included the right to issue "licenses" to users for a one-time minimal fee. Our intention going forward is to own the copyright to additional courses. This is truly "a big deal" and trust that you are rejoicing with us. Here why it is important for us to take this step.

- ► If a copyright owner decided to revoke this privilege, our extensive curriculum would be diminished, leaving a vacancy in what we offer. We could find an author to replace it but at a time and financial sacrifice. The new material may lack in quality and proved effectiveness.
- ▶ In the event of the death of a copyright owner, the copyright could pass to a surviving family member or others; creating the need to renegotiate a new agreement-if possible-or risk the loss of the privilege. The uncertainty would put Family Upreach, Inc. in a precarious position at best.
- As with any written material, there is a need to update both its appearance and content. In the use of results of research, statistics cited should not be older than 4-5 years. More recent results may not alter conclusions but are essential to creditability and validity. New research work may be performed by anyone but only the copyright owner has the authority to change the text.



We are overjoyed with this development. We believe our generous donors and those who teach this material are also happy with this development. But it also means a monumental task is staring us in the face. It involves eleven of our fifteen courses. So, it includes thirteen lessons multiplied by 11 courses or 132 lessons and 1.584 letter-size pages! We solicit your patience and prayers. We do not want to slow down in other ongoing aspects of this good ministry.
